Eligible 8<sup>th</sup> grade students are invited to participate in a special, end of the year celebration aboard the *Mystic Blue*, located at Navy Pier in Chicago.

The trip is scheduled for **Wednesday, May 23, 2018**. Students will come to school at their regular time, and then be transported by bus to Navy Pier for a day on the water! They will return before the day's end so that bus riders will be able to get home, without making special arrangements for pick-up.

The cost of the trip is \$65.00. Students are expected to wear school appropriate clothing for this event. Our 8<sup>th</sup> grade teachers, staff and administrators will be chaperoning the students.
